ALL IMPORTERS

The Australian customs Service require that all Customs Brokers who act on behalf of an Importer have a current Authority to Act in their possession. Customs may and do request us to produce our Authority to Act at different times.

The Customs Act (Sec 181) requires that owners of goods provide an Authority to Act to permit their Customs Broker to act on their behalf. Where an Authority to Act is not retained, a breach of the Customs Act occurs, where an administrative penalty may be incurred.

AUSTRALIAN WINNER GLOBAL LOGISTICS (AWGL) also required by GST legislation to obtain your authority to allow us to quote your Australian Business Number (ABN) on any import declaration. We have therefore included this requirement into the attached Authority.

The importer is required to pay the Customs duty, GST, Customs/AQIS processing fees, airport/wharf charges, local cartage, etc, unless the shipment term is DDU or DDP. Please also note that changing of delivery address or require special delivery services (eg. delivery on public holiday, require AWGL to arrange equipment to unload, etc.) might cause extra costs at the importer's account.

It is imperative that we receive your Authority to Act for (both air & sea) as soon as possible. Failure to have your Authority to Act may result in delays (storage might be occurred) in processing your documentation until your authority is received.

The enclosed Authority to Act must be completed on company letterhead, or include a company stamp with sufficient details to identify the owner of the goods.

We are able to accept your authority either by fax or scanned attachment to an email. You are deem to fully understand and accept the standard trading terms and condition (can be viewed and download from our website www.awg-logistics.com.au or www.auwintl.com/en) if use our services.
